It took Apple 42 years to reach a \$1 trillion market capitalization but Wednesday it reached the \$2 trillion mark only 2 years later. Pepperdine University recently released its [2020 Private Capital Markets Report](#) which **allows you to measure yourself and your business against the greater marketplace** to assess if your firm has reached its "Goldilocks Zone". Below are a few benchmarks:

- 23% of investment bankers closed 6 deals or more; **71% closed between 1 and 5 deals**; 6% of respondents didn't close any deals in the last 12 months
- 76% of deals ended in a closed transaction and **24% of deals terminated without a transaction** over the past 12 months
- The **top 3 reasons for not closing a transaction** were valuation gap (31%), unreasonable seller or buyer demands (19%) and lack of capital to finance (13%)
